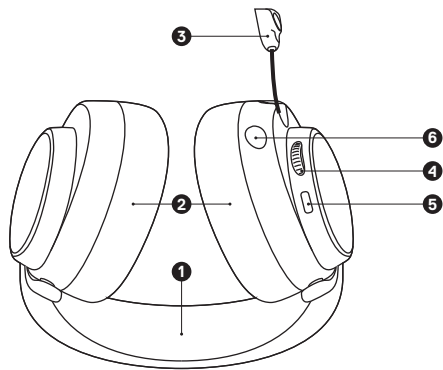

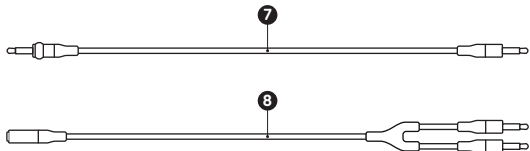

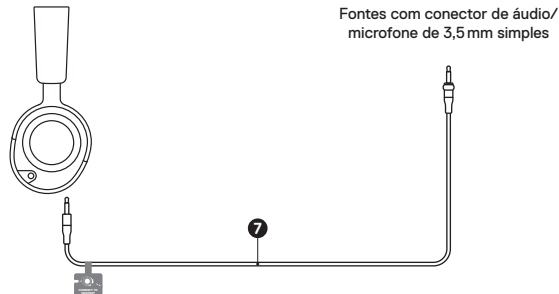

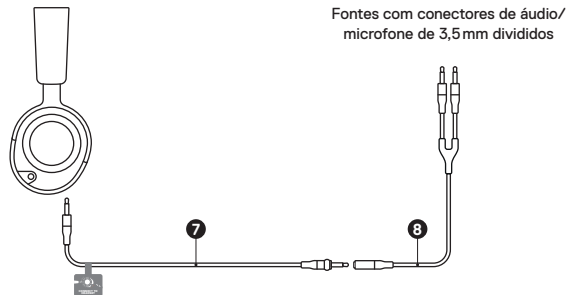

LIGAÇÕES DE 3,5 MM DUPLAS

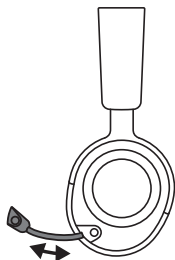

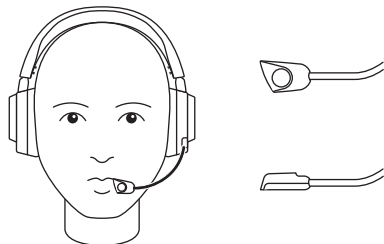
O *Microfone ClearCast retrátil (3)* vem retraído de fábrica. Para utilizar o microfone, desliza-o até atingir a sua extensão total.

Posiciona o *Microfone ClearCast retrátil (3)* perto do canto da boca com a superfície frontal voltada para ti.

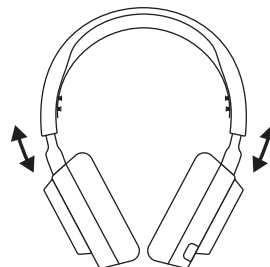

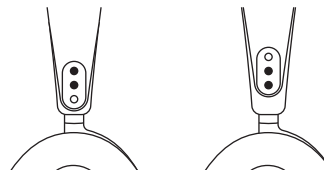
AJUSTE PERFEITO
